## REGULAR MEETING

August 13, 2018

The regular, August 13, 2018, meeting of the Hancock Township Board was called to order by clerk, Rick Hauswirth., with all members present. Clerk Hauswirth explained to the board that according to Lansing's Attorney it was necessary to appoint a new Supervisor within 45 days of Paul's death. He reported that Trustee Ken Moyle was interested in the position and if there were no objections from the board he would begin his new position tonight. Before he could accept the position of Supervisor he must resign from his position as Trustee. The clerk has a letter of his resignation on file. Clerk Hauswirth also has a letter of resignation from Julianne Haischer resigning her Deputy Clerk's position. She was then appointed the Trustee position abandoned by Trustee Moyle. Lisa Moyle accepted the position of Deputy Clerk left vacant by Julianne Haischer's resignation. A roll call vote was held regarding the appointments. Richards, yes, Hauswirth, yes, Moyle, yes, Racine, yes. MOTION CARRIED

The minutes of the previous monthly meeting were read and approved.

It was moved by Trustee Racine and supported by Trustee Haischer to accept the Treasurer's July 2018 report with a total fund balance of \$233,183.27 as presented by Treasurer Richards. MOTION CARRIED

It was moved by Trustee Haischer and supported by Trustee Racine to pay the July bills totaling \$ 10,054.69. Vouchers 11590-11617. MOTION CARRIED

REPORTS: Fire man Giacoletto reported there were two call last month. All trucks are running well. Pete reported the Chicken Barbeque netted \$6,100.00.

CEMETERY: According to Pete everything is quiet at the cemetery.

OLD BUSINESS: The audit report is in.

NEW BUSINESS: Mrs. Kemppainen brought all the supervisor information that Paul had at home in for the new supervisor.

The election crew working the August election had trouble sending the totals to the County Clerk after the election. According to the IT person that was called in, the
