Regular Meeting

March 11, 2019

The regular March 11, 2019, meeting the Hancock Township Board was called to order at 7:26 P.M., by Supervisor Moyle, with all members present with the exception of Rick Hauswirth.

The minutes of the previous monthly meeting were read and approved as presented.

It was moved by Supervisor Moyle and supported by Trustee Racine to accept the Treasurer's report with a total fund balance of \$174,209.29 as presented by Treasurer Richards.

REPORTS:

Fireman Giacoletto reported there were no fire calls. Only text message regarding the snowmobile accident on Lake Annie Road.

First responders can go in under Dollar Bay. \$5,000.00 to \$6,000.00 per year. Usually do fund raisers to raise money or small fee's on calls. Training is in April, May, and June.

There is a 25/75 grant for flood midigation. Can use for culverts, etc. Notice of intent due by April 5, 2019.

OLD BUISNESS:

Marijuana Ordinance: Motion to have a public hearing was made by Trustee Haischer and seconded by Treasurer Richards. Vote: Richards-Yes Haischer - Yes Moyle-No Racine-No Since there is no deadline to opt out, it was decided to wait until the new Treasurer is hired and Clerk Hauswirth is back.

Township Hall addition: Talked about the proposals. Tabeling for now. Have to find the drain field.

NEW BUSINES:

There are three people interested in the Treasuere's position. Jim Moore, Terry Bray, and Mike Lawrance. Trustee Racine nominated Jim Moore for the position. The vote was Racine-Yes Haischer-Yes Moyle-Yes Richards-Yes MOTION CARRIED

97 1/2% of summer taxes have been collected. 12 people sent to County.

93.8% of winter taxes have been collected. 32 people sent to County.

Lost 2 parcels due to Vet's not having to pay property taxes. Loss = \$583.50

Clerk Hauswith mailed a grant for a new laptop computer for the Treasurer on 2/14/19.

Treasurer Richards made a motion to get the specs for a new laptop and purchase one.
It was seconded by Trustee Racine. MOTION CARRIED

A new Task Force is being made for the new jail. Township might want to appoint someone to be on it. Should be getting information soon.


CORRESPONDENCE:
