REGULAR MEETING

October 8, 2018

The regular October 8, 2018, meeting of the Hancock Township Board was called to order at 7:00 P.M., by Supervisor Moyle, with all members present.

The minutes of the previous monthly meeting were read and approved as presented.

It was moved by Trustee Haischer and supported by Trustee Racine to accept the Treasurer's report with a total fund balance of \$203,014.17 as presented by Treasurer Richards. MOTION CARRIED

It was moved by Trustee Racine and supported by Trustee Haischer to pay the September bills totaling \$6279.16. Vouchers # 11643 thru 11661.

REPORTS:

The next Board of Review Meting will be on December 11, 2018.

Fireman Giacoletto reported the fire hall had three calls this month: One car wreck, and two false alarms. The generator on truck number 25 PTO is shot. Bekkala Diesel Repair is trying to find parts, but they are not readily available.

There will be a Spaghetti Dinner at the hall on October 13, 2018. The cost of the tickets is \$10.00.

Mr. Giacoletto had the hall sprayed for flies. He hasn't gotten the bill yet. He will pay it if he gets it before the next meeting.

OLD BUSINESS: Paying all township bills by credit card was discussed. Supervisor Moyle will look into different credit cards to see what they have to offer. He will also move the payment date to the end of the month so we will not incur past due charges.

NEW BUSINESS: Bids for snow removal are needed by the November meeting.

The light above the main door is not working and needs to be replaced.

Treasurer Richards reported that 25 out of 498 customers have not paid their taxes.

In addition, the previous Deputy Clerk, Julianne Haischer's authorization shall be rescinded from signing the General Fund checks. The motion was seconded by Rick Hauswirth and passed with a four to zero roll call vote. MOTION CARRIED

The subject of Bright House was brought up by Clerk Hauswirth. He has been dealing with them about deceased Supervisor Kemppainen's investment. He has been running into many roadblocks and getting the money to Paul's wife has been very difficult. He suggested that the board look into investing with local investment companies such as Edward Jones and Trivent.
